## DeerTrax Dealer Agreement

Between:

(Herein referred to as 'Prism')

Dealer agrees to receive orders for DeerTrax software on a commission basis. The commission amount is 20% of the sales price before any special pricing or discounts. This amount, as well as the sale price of DeerTrax, may be amended by Prism at any time with at least 30 days notice to dealer.

Where product pricing differs for an alternate-language or customized version of DeerTrax, the commission rate remains based on the regular version price, unless otherwise specified or agreed upon.

Dealer agrees to send order information (through fax or online) to Prism, along with appropriate payment information, within 48 hours of the order being received by dealer. Once the information is received by Prism, a copy of DeerTrax will be shipped directly to the customer.

If dealer intends on attending a tradeshow or event to sell or promote DeerTrax, dealer agrees to notify Prism with at least 30 days notice. This ensures that another dealer will not be at the same event selling the same product.

Dealer is not expected to handle customer support for DeerTrax. All support calls are handled through Prism's toll free phone number or by email.

There is no minimum sales quota; however, long periods of sales inactivity could result in the termination of this agreement.

Prism agrees to send sales commission funds to dealer on a monthly basis, or on a mutually agreed upon schedule. Funds will be sent in the form of a cheque or money order in Canadian dollars.

Dealer agrees to not make any statements or implications that they are employed by or are official agents of Prism.

Prism may, at its sole discretion, limit the number of dealers in a specific region, but has no obligation to do so.

Dealer has the right to use, display, and distribute the DeerTrax name, logo, and promotional materials within their sales region. Any print advertising for publication in trade magazines, newsletters, or websites, must be approved in advance by Prism.

Prism may terminate this agreement at any time without explanation or notice. Prism may modify this agreement at any time with at least 30 days notice to dealer. Dealer may terminate this agreement with at least 15 days written notice to Prism.
